

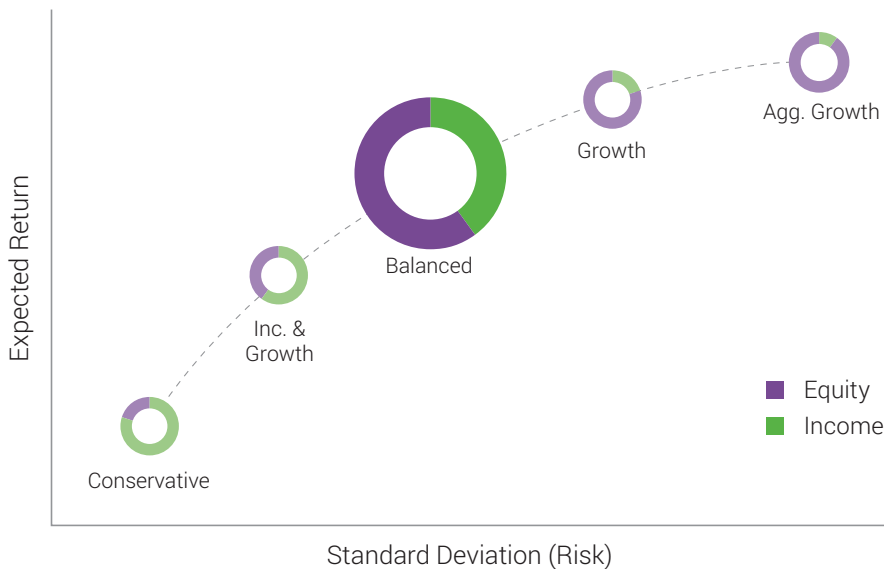
MORNINGSTAR BALANCED ETF ASSET ALLOCATION PORTFOLIO CLASS I

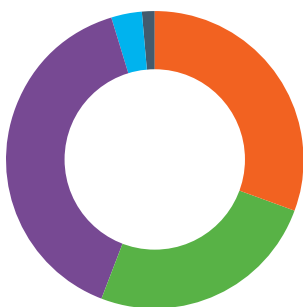
Morningstar Asset Allocation Portfolios Expand the Efficient Frontier
