

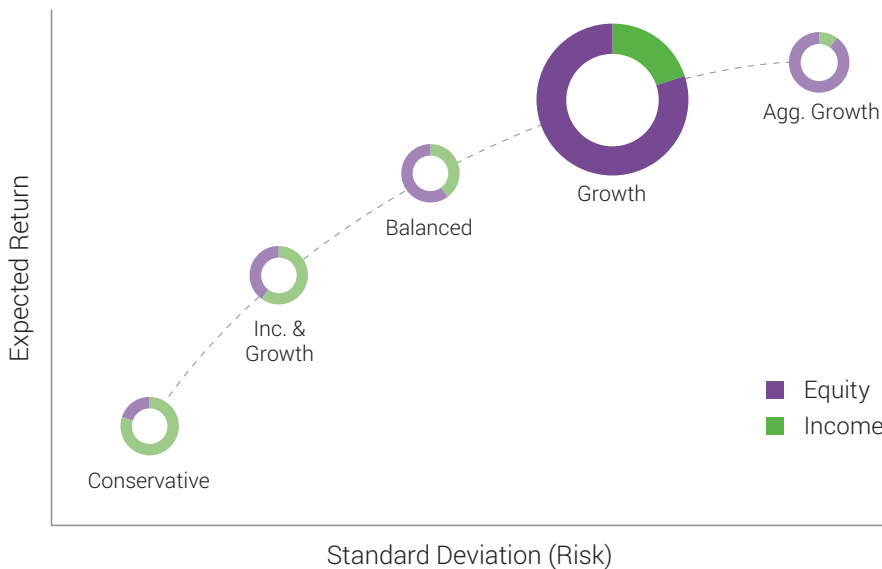
# MORNINGSTAR GROWTH ETF ASSET ALLOCATION PORTFOLIO CLASS I

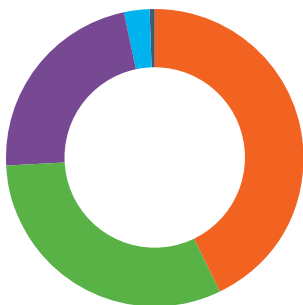
## Morningstar Asset Allocation Portfolios Expand the Efficient Frontier
