Description

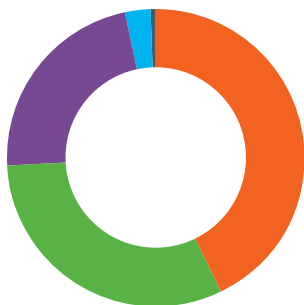
Morningstar Asset Allocation Portfolios Expand the Efficient Frontier

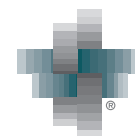
