

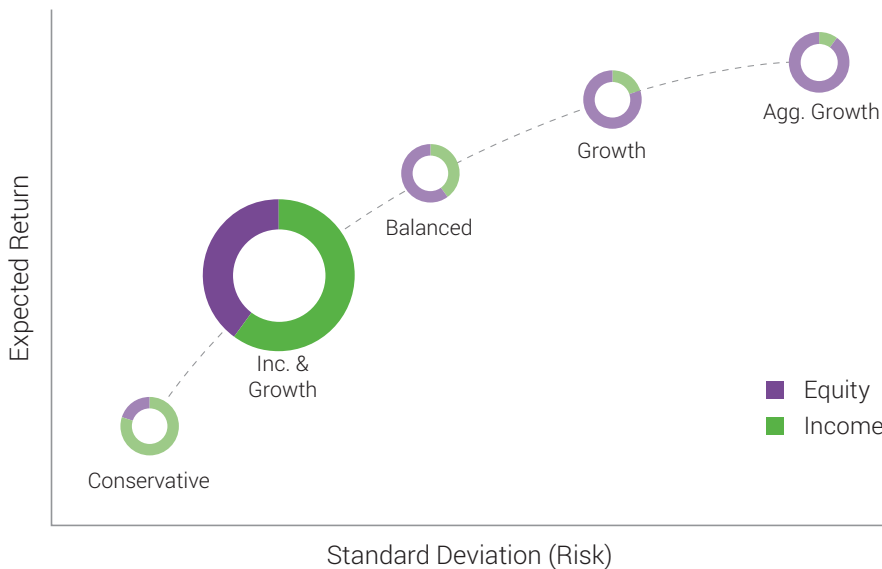
MORNINGSTAR INCOME AND GROWTH ETF ASSET ALLOCATION PORTFOLIO CLASS I

Description

A smaller portion of the Portfolio is invested in ETFs that primarily invest in equity securities of large, medium and small sized companies.

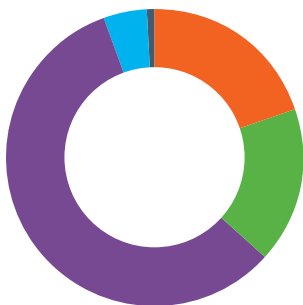
Morningstar Asset Allocation Portfolios Expand the Efficient Frontier
