Monthly Insights | September 2020

Key Takeaways

- The ALPS Clean Energy ETF (ACES) gained 3.56% in September 2020, despite a down month for the broad market.
- Biomass/Biofuel was the best performing segment, with one underlying name driving the bulk of the performance.
- Renewable Energy Group Inc. (REGI; 2.72% weight*), a biofuel name, was the top performer in ACES after the Trump administration refused to grant ethanol blending waivers to refineries.

Performance

- The ALPS Clean Energy ETF (ACES) gained 3.56% in September 2020, but trailed the WilderHill Clean Energy Index (ECO). ACES, however, did outpace the S&P 1000 Index (SPK) by 7.23% as broad markets sold off. The outperformance by ECO was largely due to its allocation to Chinese Solar names, just as in August 2020.
- The US energy storage sector is growing fast despite virus headwinds. The US energy storage sector is heating up even amidst a pandemic, with quarterly deployments reaching 168MW, just shy of the Q4 2019 record of 186MW. Q2 deployments were a 117% increase year over year and are expected to increase into Q3 and beyond. While much of the demand has come from California and Hawaii residential customers, utility scale deployments are increasing at a rapid pace and are expected to increase further in coming quarters.



Attribution

- Biomass/Biofuel was ACES best performing segment this month while EV/Storage, which added three new securities in the September rebalance, was the laggard.
- Biomass/Biofuel led all segments higher as Renewable Energy Group Inc. (REGI; 2.72% weight*) was the best performing security in ACES this month. In addition to an analyst price target raise, the EPA also said it won't allow retroactive exemption from the biofuel blending requirements, under the Renewable Fuel Standard, benefitting the biofuel company.
- EV/Storage experienced a down month, with three new names being added to the segment, joining Tesla Inc. (TSLA; 4.71% weight*). One of those names was Workhorse Group Inc. (WKHS; 3.06% weight*), an electric vehicle manufacturer. Workhorse was down mostly on general industry sentiment after Nikola Corp (NKLA; not in ACES) fell hard after fraud allegations. Workhorse, however, is still up 731.58% year to date.

Valuation

- ACES's underlying index, the CIBC Atlas Clean Energy Index, has a price-to-earnings ratio (P/E ratio) of 35.55x, a premium to both the WilderHill Clean Energy Index and NASDAQ Clean Edge U.S. Liquid Series Index.
- ACES ~31% weight to utilities is within more expensive Yieldco's, which garner higher P/E's but lower P/CF (Price to Cash flow) metrics.



Company: **Blink Charging Co.**
(BLNK; 0.32% weight*)



Segment:
EV/Storage

- Despite a down month for the EV/Storage space, new fund addition, Blink Charging Co, gained 22.88% since being added to ACES on September 18, 2020. The company develops electric charging stations.
- With all the volatility in the EV space in September, Blink Charging was one of the lone bright spots after a few pieces of good news:
 1. California announced that, starting in 2035, they will ban the sale of new gasoline powered vehicles in the state.
 2. They sold/deployed 539 EV charging stations amid COVID lockdowns in June, July & August. A near 100% increase over the same period in 2019.
 3. Blink acquired Los Angeles carsharing service, BlueLA, doubling the number of Blink Stations in the area. "California is the epicenter for EV adoption, and this acquisition significantly expands our market presence and strategically positions Blink as the City of Los Angeles' contractor for its EV carsharing program with EV charging"¹ – according to the press release.
- BLNK is up 454% year to date.

Clean Energy Sector Risk. Obsolescence of existing technology, short product cycles, falling prices and profits, competition from new market entrants and general economic conditions can significantly affect companies in the clean energy sector. In addition, intense competition and legislation resulting in more strict government regulations and enforcement policies and specific expenditures for cleanup efforts can significantly affect this sector. Risks associated with hazardous materials, fluctuations in energy prices and supply and demand of alternative energy fuels, energy conservation, the success of exploration projects and tax and other government regulations can significantly affect companies in the clean energy sector. Price/Earnings Ratio – A valuation ratio of a company's current share price compared to its per-share earnings.

Price/Book Ratio – The weighted average of the price/book ratios of all the stocks in a portfolio. The P/B ratio of a company is calculated by dividing the market price of its stock by the company's per-share book value.

Price/Cash Flow Ratio – This represents the weighted average of the price/cash-flow ratios of the stocks in a portfolio. Price/cash-flow represents the amount an investor is willing to pay for a dollar generated from a particular company's operations.

Price/Sales Ratio – This represents the weighted average of the price/sales ratios of the stocks in a portfolio. Price/sales represent the amount an investor is willing to pay for a dollar generated from a particular company's operations.

The NASDAQ Clean Edge U.S. Liquid Series Indexes are modified market capitalization weighted indexes designed to track the performance of clean-energy companies that are publicly traded in the U.S.

The WilderHill Clean Energy Index is a modified equal dollar weighted index comprised of publicly traded companies whose business's stand to benefit substantially from societal transition toward the use of cleaner energy and conservation. The index benchmark value is 100.00 at the close of trading on December 30, 2002. * Disseminated by AMEX *

The S&P Global Clean Energy Index provides liquid and tradable exposure to 30 companies from around the world that are involved in clean energy related businesses. The index is comprised of a diversified mix of Clean Energy Production and Clean Energy Technology and Equipment Providers companies.
